Lake Central Modifications to in Person Instruction Protocols 2021-2022 Includes Updates in Response to the Indiana Department of Health webinar on 1.20.22

The following guidance has been given by recognized health experts and will be used in all Lake Central facilities beginning August, 2021. Given that guidance regarding maintaining in person instruction will change, LCSC will take definitive guidance from the CDC, ISDH or Lake County Department of Health if they provide it. Federal, state, and local mandates *will* continue to change.

#### Masks

- Masks on all school buses and all forms of public transportation have been mandated in CDC guidance.
- Masks are strongly recommended by the CDC, ISDH and Lake County Board of Health. Masks
  are mandated for Lake Central students at all developmental levels until changed by the Board.
  The administration and Board are closely following infection rates, hospitalization rates, Indiana
  Department of Health guidance, Governor Holcomb's executive orders, and legislation enacted
  by the Indiana General Assembly which will determine when masks may become optional.
- Masks are not required at extracurricular events
- As long as the terms of <u>Governor Holcomb's Executive Order 21-34</u> remain in effect, the masking
  and associated quarantine guideline contained within will be followed. The order states that if
  everyone is masked in a school, then close contacts of positive Covid-19 students do not need to
  be quarantined. Instead, they need to monitor for any symptoms and should stay home if they
  arise. Close contacts of positive cases in situations where students are unmasked, like while
  eating or during extracurricular activities, will still result in a quarantine. (see below)
- If this guidance is extended by Governor Holcomb, it will remain in place for the Lake Central School Corporation.

# **Vaccines**

- The CDC states that "vaccination is currently the leading public health prevention strategy to end the COVID-19 pandemic."
- Lake Central School Corporation is not mandating the vaccine for students or staff members.

# **Quarantine Guidance**

- Students or staff with a positive test must quarantine for five days, should be isolated if others
  in the household are unvaccinated, and may return on the sixth day after the positive test
  provided individual is fever free for 24 hours. Individuals returning on the sixth day must eat
  lunch at least 6 feet away from other unmasked individuals. (IDOH Isolation Guidance)
- Beginning on Monday, January 24, 2022, Lake Central will follow the latest guidance regarding
  notifying close contacts who are masked. The most recent IDOH guidance regarding the time
  required to stay home for both positive individuals and unmasked close contacts, (lunch and
  sports) has also been reduced to 5 days provided the close contact is fever free for 24 hours
  prior to returning to school. (IDOH Quarantine Guidance)

# **Notification of State and Local Health Officials**

- As in the past, per I.C. 20-33-2-47, LCSC will notify the county health department any time student absence reaches 20% in any school.
- As was done last year, all COVID positive data will be shared with the State of Indiana through the Gateway portal which also notifies the county health department each time a school submits data.
- As of 1.21.22, the state is only requiring schools to submit positive case data.

# **Reporting Data to Stakeholders**

• The Superintendent will continue to post COVID positive data and quarantine data for students and staff members on a weekly basis.

### **Mitigation Options**

 As was the case last year, students at times will be in close proximity to one another while on buses and at school. Masks/face coverings are the one option that we will utilize to minimize the spread of COVID and reduce the need to quarantine students and staff members in our schools.

#### **eLearning**

- Students will be permitted to "listen in" to the lecture part of class in the event they are at home due to being COVID positive or are a close contact quarantine. Teachers main focus will be on the students that are physically in the classroom.
- eLearning will also be used in case a weather event causes school to be closed. If the event lasts more than 2 days, the third day and beyond will be made up at the end of the school year.
- Classrooms or schools closed due to an outbreak of COVID cases will utilize eLearning for the duration of the closure.

### **Cleaning Practices**

• Lake Central will continue to employ the 11 department members that were added in the spring of 2019 and will clean all areas of every facility as was the practice last school year.

### Cafeteria Use

Cafeterias will be used similar to the 2019-2020 school year.

### **Drinking Fountains**

- Students are encouraged to bring personal water bottles to school.
- Drinking fountain use will be limited to refilling personal water bottles for this school year.

# **Athletics and Marching Band**

- LCSC will follow crowd restrictions or other protocols at home events should the county department of health mandate them.
- LCSC has not mandated masks at extracurricular events because they are voluntary activities unlike in school learning which is the only option for our students.
- Lake Central will follow any guidelines set forth by the IHSAA and ISSMA.

# **Visitors to School**

 Volunteers must provide proof of a negative test from a clinic or pharmacy that is conducted no more than 36 hours prior to the time of volunteering. LCSC will accept any negative test for this purpose as long as it is recent as explained above. It is likely that our schools will utilize fewer volunteers than in prior years

It cannot be stated enough by our administrative team that maintaining in person instruction for our students is our highest priority. We want to reiterate that masking allows us to avoid quarantining close contacts with the exception of those experiencing symptoms or when students are unmasked at lunch or during extracurricular activities.
